## How to Access Online Mediation

- All you need is a quiet private place where you won't be disturbed.

## FREE Mediation

The Family Mediation Voucher Scheme was created to financially support individuals who may be able to settle their family law disputes outside of court.

We can apply for a voucher from the Ministry of Justice on your behalf which will provide up to £500 to cover the cost of mediation.

To be eligible, the dispute needs to be in relation to the children. You will only need to pay for the initial session known as the Mediation Intake and Assessment Meeting (MIAM)

Receiving the document you need can be **quick, easy and simple.**

- You need a C100/Form A to make a court application.
- You need to attend a MIAM before you can make a court application.
- Book your appointment today- next day appointments are often available.

## Our Costs

## What is a MIAM?

A Mediation Intake and Assessment Meeting (MIAM) is the first step in mediation. The MIAM allows you to find out more about the mediation process and if it is suitable for you.
